The Call for Sessions is now open for the 2017 American Planning Association – Oklahoma Conference! The statewide conference will be held at Claremore Conference Center in Claremore, OK from October 8-10.

The theme of the conference is “**Planning in a Connected World**”, and we encourage you to think broadly and creatively when drafting your session proposal. Proposals do not have to be a traditional presentation or panel discuss. Interactive and hands-on sessions are welcome.

You are invited to submit proposals for presentations to be included in the 2017 conference program. The conference will include a range of topics and speakers with a variety of experiences and backgrounds, including leading experts and practitioners, as well as young and emerging professionals with new ideas.

Preference will be assigned to sessions that are eligible for AICP Certification Maintenance (CM) credits. All sessions will be 1 hour and 15 minutes with the exception of 1 hour and 30 minute sessions for law and ethics courses.

Session Review: All proposals will be reviewed to ensure that the sessions chosen for the conference program reflect innovation and diversity in planning research, practice, education, and professional development. Presentations that market specific products, vendors, and services will not be accepted. The Conference Committee reserves the right to combine session proposals.

Email notifications of selected sessions will be issued to session organizers by August 31, 2017.
